Congratulations!

You are reading this Newsletter having lived through an academic year like no other in our lifetime. Our lives have been disrupted unimaginably. The coronavirus pandemic has touched all our lives. No child or adult has been spared in the United States and across the world. We are living through a crisis of a lifetime, and we have yet to observe its full impact.

Global pandemics and a variety of health crises occurred throughout history. We may be sure that they will happen again. What have we learned?

How may we go forward today and every day wiser for having endured this national and international public health crisis?

Elizabeth Farrell (1870-1932), Foundress of CEC in 1922 lived through the 1918 influenza outbreak. This historic public health crisis is documented at length in *The Great Influenza: The Story of the Deadliest Pandemic in History* (Barry, 2018).

Govermental/Legislative Corner

The Illinois General Assembly Spring Legislative Session ended on Tuesday, June, 1, 2021. Please note the following highlights:

- 1. An end to restraint and seclusion in schools passed phase out the use of isolated time-out and physical restraints in public schools, charter schools and special education non-public facilities over the next three years.
- 2. Special Education Maximum Age Extension Students with disabilities between the ages of 18-21 can continue receiving services until the end of the school year rather than the day before their 22nd birthday.
- 3. The Right to Play Every Day starting June 1 students from K-5 will play for 30 minutes every day. Children cannot be excluded from playtime as a punishment. Students with disabilities must have accommodations to participate in playtime.

Illinois School Code Amendments:

Local Legislation

Status: Enacted - Act No. 164

Summary: Amends the School Code, provides that with regard to special education joint agreements, under no circumstances may a petition for withdrawal from a joint agreement be presented to other member districts less than a certain number of months from the date of the proposed withdrawal, provides that if a petition for withdrawal is not approved by the other member districts, any petitioning member district may appeal the disapproval, provides that the Trustees of schools of the township having jurisdiction.

Illinois School Code Amendments continue:

Special Education

Status: Enacted - Act No. 220

Summary: Provides that, for an early childhood education endorsement, an individual may satisfy the student teaching requirement of his or her early childhood teacher preparation program through placement in a setting with children from birth through grade two, and the individual may be paid and receive credit while student teaching. School Code

Date of Last Action: 08/23/2019 - Enacted Summary: Amends the School Code, provides that a school district must utilize response to scientific, research based intervention or multitiered systems of support as part of an evaluation procedure to determine, if a child is eligible for special education services due to a specific learning disability and may utilize the data generated in an evaluation to determine if a child is eligible for services in another disability category.

Elizabeth Farrell

Elizabeth Farrell, Foundress of the Council for Exceptional Children lived through the great influenza pandemic during the winter of 1918. This pandemic raged for up to two years and as many as 100 million people died worldwide. We thank Dr. Kimberly Kode Sutton for her informative presentation on Zoom on Friday, March 19. Dr. Sutton wrote a book titled *Elizabeth Farrell and the history of special education* (2nd ed.) published by the Council for Exceptional Children in 2017. We will be learning much more about the life and times of Elizabeth Farrell as we gear up to celebrate 100 years of special education. The Council for Exceptional Children began on August 10, 1922. Following a meeting with 11 attendees at Teacher's College Columbia in New York City the International Council for Exceptional Children was established and Ms. Farrell was unanimously elected president. The two principles that guided her work in this organization were collegiality and best practice in the education of children and adolescents with special learning and behavior needs. Today her dream is alive and well in Illinois, all over the United States, and across the world.

Exceptional Children's Week

We celebrated Exceptional Children's Week from May 3rd to the 7th 2021 in the State of Illinois #ECW. The proclamation to declare this week as ECW was approved by Governor J.B. Pritzker. Various schools, organizations, and institutions celebrated students' and their accomplishments in Academics, Art, School and Community, Self-Advocacy, Technology, and Transition. We participated in a themed week that involved dress-up days, social media posts, encouragement, and spirit!

Additionally, ICEC's Podcast Chair Michael Arrigoni interviewed Children's Book Author, Lindsey Frank. She discussed important topics related to working with students who have exceptionalities and their families, Social-Emotional Learning, and Mindfulness. Ray Graham and the history of Illinois Council for Exceptional Children

In 1976 the United States celebrated the Bicentennial. To memorialize this occasion, Illinois Council for Exceptional Children sold a commemorative coin in honor of the Ray Graham. The coin is 1½" in diameter and an accompanying tribute included the following words:

Illinois Council for Exceptional Children: A Federation of Council for Exceptional Children

Ray Graham was the first Director, Division of Special Education, Office of Superintendent of Public Instruction, State of Illinois. He served in this position from 1943 – 1961. Prior to this time, he had served as a teacher, principal, and superintendent. Ray Graham was the force behind the founding of Illinois CEC and served as a national CEC President.

He was the author of the Illinois Plan for Special Education, an author and lecturer, and a friend to all exceptional individuals. Because of him, CEC is known as the 'society of the concerned.'

At the time of his death, the Springfield CEC Chapter #102 established the Ray Graham Memorial Fund in memory of his work in special education. Since 1962, the Illinois CEC Federation has maintained this fund in his honor. The fund is maintained by contributions from CEC members and chapters and other individuals.

This commemorative coin is in acknowledgement of your generous contribution to the Ray Graham Memorial Fund.

Mr. Graham's full name was James Ray Graham (1898-1961), who was survived by his second wife Bessie, his son James R and two grandchildren. He is interned at Oak Ridge Cemetery, Springfield, IL. Plot – Block 42B.

James Ray Graham received an honorary doctorate degree from Monmouth College. Today several schools across Illinois honor him with his name. How many of you have received a Grant from his Memorial Fund?
