Illinois Pioneers, Beverley Johns, Joyce Meyer, and Iris Kerbis Cantor reflected on the amazing people who went before us in ICEC. We looked back and found inspiration in the work of people like Clarissa Hug, Ray Graham, Sam Kirk, Robert Abbott, and so many more. They prevailed over enormous odds, such as, lack of resources, lack of legal mandates, and lack of theoretical and empirical support for their work. They were pathfinders! They made pathways where there were none, while they walked bravely in the footsteps of Elizabeth Farrell (1870-1932). Melissa Taylor, Assistant Superintendent, Belleville Public School District 118, Bellville, IL conducted an analysis of today's challenges and Cody Pullium, special education teacher, Morton High School, Morton, IL provided a response. Jamillah Gilbert, doctoral student at ISU ended this session with a reflection of the future of our profession in Illinois. **The CEC Special Education Legislative Summit 2022 (SELS)** was held at the Westin Hotel in Arlington, VA July 10-13. This special event was sponsored by CEC and the Council for Administrators of Special Education (CASE). At least, 250 special educators and related personnel from across the country gathered to organize and conduct visits to their Representatives in Congress. Dr. E. Paula Crowley, President of ICEC was among these advocates.

On Sunday afternoon and Monday July 10 and 11 the participants in SELS spent time learning how to advocate for special education with their Representatives in Congress. They discussed the needs of our time and focused on three main concerns: (a) the shortage of special education personnel; (b) mental health; and (c) full funding of the Individuals with Disabilities Education Act (IDEA).

Of the advocates assembled, up to 20 of them comprised Team Illinois. Each team organized and went Capitol Hill and visited with their Representatives. They formed teams of three and off they went with a plan! For example, on Tuesday, July 12 one group from Team Illinois met in the Longworth Building and visited the offices of Representative LaHood, Bost, Newman, and Davis.
